International Day of the World's Indígenous Peoples 9 August, 2014

"The interests of the indigenous peoples must be part of the new development agenda in order for it to succeed. [...] Together, let us recognize and celebrate the valuable and distinctive identities of indigenous peoples around the world. Let us work even harder to empower them and support their aspirations."

Secretary-General Ban Ki-moon

The United Nations adopted the Declaration on the Rights of Indigenous People in 2007, and it has since been ratified by 143 countries, including Australia. The UN estimates that there are around 400 million Indigenous people worldwide, making up more than 5,000 distinct tribes across 90 countries. Indigenous Peoples represent 90% of the world's cultural diversity despite being only about 6% of the world's population. The characteristics of tribal and Indigenous peoples are outlined in the following table.

Elements of tribal peoples	Elements of Indigenous peoples
Traditional life styles	Traditional life styles
Culture and way of life different from the other segments of the national population, e.g. in their ways of making a living, language, customs, etc.	Culture and way of life different from the other segments of the national population, e.g. in their ways of making a living, language, customs, etc.
Own social organization and traditional customs and laws.	Own social organization and political institutions
	Living in historical continuity in a certain area, or before others "invaded" or came to the area.

Indigenous peoples own land that holds 80% of the world's remaining biodiversity. In many parts of the world Indigenous people have been forced off their lands by others (e.g. mining and logging companies) seeking to exploit the resources on their land, often violently and illegally. Indigenous peoples all over the world have suffered from similar violence and disadvantage. The rights recognised under the Declaration on the Rights of Indigenous Peoples

constitute the minimum standards for the survival, dignity and wellbeing of the indigenous peoples of the world (Article 43).

The Declaration recognises the human rights of Indigenous peoples to:

- self-determination
- land and natural resources
- developing and protecting cultural, political, religious and educational institutions, and intellectual property
- freedom from discrimination, assimilation and destruction of culture
- economic and social development
- environmental conservation
- free, prior and informed consent, consultation, and participation in decision-making
- fair and mutually acceptable procedures for conflict resolution
