#### The Multiplier Effect

For each biennium, the Zonta International Foundation sets the operational fundraising goals for international service, education and prevention of violence. In addition, the Zonta International Service Program which seeks to improve the legal, political, economic, educational, and/or health status of women in developing countries or countries in transition, determines which International Service projects will be funded for the biennium. In supporting these projects, The ISP works collaboratively with the United Nations so that Zonta donations are contributing to UN funds which are earmarked for these identified projects, including United Nations Children's Fund (UNICEF), United Nations development Fund for Women (UNIFEM) and United Nations Population Fund (UNFPA).

Obviously the decision to support a particular project is not whimsical but has been well researched and "costed" in terms of the amount of funds needed to attain predetermined achievable goals. In the same way that ZI contributes to existing UN projects to increase the effect of their work, we as clubs contribute to ZIF to increase the effect of their projects. We are all aware that collectively our donations have a greater impact servicing a designated few projects rather than individually trying to support many different projects. There in lies the multiplier effect.

Each of us is very keen to support our local projects (charity begins at home) but as members of Zonta International we are legally, morally and ethically obliged to follow the rules and guidelines of ZI. This does include contributing one-third of our fundraising dollars to ZI projects. We as a club do get to decide which of those projects we want it to be. The fact that our membership fees go to administration and we can be assured that our whole dollar goes to our designated project is the very aspect of Zonta we all appreciate.

The table below provides you with a brief overview of ZI projects for the 2008-2010 biennium and the funding goals set and those given at 31 December 2008. As you will notice our donation is very small within the big picture but together with lots of other small donations, we can be contributing to a much bigger project which would otherwise be unachievable on an individual basis.

#### The Amazing 5 Minute Chocolate Cake

This is an easy way to make a small cake in a couple of minutes or as a quick dessert. Grandchildren love to make it!

Use a bowl suitable for microwaving.[ I use a 500ml Pyrex measuring Jug.] Into the bowl place

4 tbsp of S.R. Flour 4 tbsp of caster sugar or plain sugar 2 tbsp of cocoa Mix these dry ingredients together.

Add

3 tbsp of milk 3 tbsp of oil 1 egg

Mix ingredients together. Add a few choc chips if you want major decadence. Put bowl or jug with the mixture into Microwave [1000w] for 3 minutes on high. The chocolate chips tend to drift to the bottom so let it cool a few minutes and when you tip it out the melted chocolate chips are then the icing to the top.
